WHEREAS, on June 9, 2009,

The Nitro FireFighters Civil Service Commission was notified by the Honorable Rusty Casto, Mayor of The City of Nitro, Kanawha & Putnam Counties, West Virginia, that vacancies exist within the Nitro Fire Department for the position of a PROBATIONARY FIREFIGHTER, and has requested the Nitro FireFighters Civil Service Commission to establish an Eligibility List for appointment to the position of Probationary FireFighter. THEREFORE, all persons desiring to seek employment with the Nitro Fire Department, City of Nitro, Kanawha & Putnam Counties, West Virginia, please TAKE NOTICE as follows:

- 1. A competitive written examination will be administered by the Nitro FireFighters Civil Service Commission on: August 18th, 2009 at 6:30pm.**
- 2. To be eligible to take the examination, each interested person must file an application with the City of Nitro Personnel Department, located in, Nitro City Hall, 20th Street & 2nd Ave. Nitro, W.Va. 25143**
- 3. Applications may be obtained beginning July 20th 2009 between the hours of 8:00 A.M. and 4:00 P.M., Monday through Friday (excluding legal holidays) Completed applications for the written examination, must be submitted to the City of Nitro Personnel Department, located in Nitro City Hall, 20th Street & 2nd Ave. Nitro, W. Va. 25143. NO LATER THAN 3:00 P.M. on August 3rd, 2009.**
- 4. Applications will be dated & timed upon receipt, on the event of an identical written score, the application received first will be considered first.**
- 5. Applicants may not be under the age of 18 years nor over the age of 35 years on the date of his or her application. Satisfactory proof of age shall be required of each applicant upon submission of his or her application.**
- 6. All applicants MUST: possess a high school diploma, or GED equivalent, have no felony convictions, have no convictions within five (5) years of a misdemeanor offense involving larceny, false swearing, gambling, or other crime indicating questionable moral character, must have no habitual use of alcohol or drugs.**
- 7. All applicants successfully completing the written examination for Probationary FireFighter shall be required to submit to the following additional examinations: Pass one or more medical examinations on the requirements of NFPA 1582 of the Standard on Medical**

Requirements for FireFighters. : Climb the 75ft. aerial ladder, Pass the physical agility examination that complies with the requirements of the Nitro Fire Department, (CPAT): A background investigation to verify all pertinent information concerning the applicant; and a Psychological test to determine the applicants suitability for appointment
